The owner gives to untimely use with the right of possession and use of the dog to the co-owner on the following conditions:
☑ The owner has the right to mate a dog and receive from it the posterity for realization, not less than and not more than times of the total number of full-fledged puppies
2 According to a separate agreement between the parties, the number of mating can be changed
The co-owner does not have the right to hand the dog to a third party without the consent of the owner
☑ In case of health problems associated with mating and / or births, if they lead to a loss of reproductive function, the mating cease and the dog is sterilized (if necessary)
1 In case of the death of the dog or its loss, as well as in the case of health problems,
associated with the inattentiveness of the co-owner (careless attitude towards the dog,
insufficient care), if they lead to loss of reproductive function,
the co-owner compensates to the owner the cost of the dog in the amount of
① The co-owner is obliged to provide timely and reliable information about the beginning of the dog's estrus and to hand the dog to the owner at the time of mating

The co-owner has the right to keep the dog during its pregnancy

The owner has the right to take the dog for the time of parturition and feeding of the puppies until their realization
☑ The co-owner has no right to sterilize the dog and / or mate it on his own without permission of the owner during the validity of the contract, otherwise the co-owner compensates to the owner the cost of the dog
The co-owner bears physical and financial responsibility for the health of the dog and the safety of its puppies during pregnancy in the amount of the cost of the dog
② The owner bears physical and financial responsibility for the costs associated with mating, birth and postnatal dog recovery
1 The co-owner has the right to trim the dog at his discretion and take it out abroad, except for the period from mating until the end of feeding of puppies
☑ In case of co-owner refusal to provide reliable information about the estrus and / or hand the dog for breeding, the co-owner compensates the cost of the dog, or the dog is returned to the owner and the contract is unilaterally terminated by the owner
In case of problems with the dog of a personal nature, the co-owner has the right to return the dog to the owner within 30 days from the date of signing the contract
• In case of a situation leading to the impossibility of further keeping the dog, the decision on further actions is taken by the owner and co-owner together
• In case of suspicion of improper care, the owner has the right to take away the dog and terminate the contract unilaterally
• The first productive mating is to be held at the second estrus, but not later than the dog will be 2 years old, otherwise the dog returns to the owner
• After fulfilling all the conditions specified in the contract, the dog remains to co-owner in unlimited use and disposal
• In the event of health problems after childbirth, not related to maintenance and / or care, due to which the dog loses reproductive ability, the dog remains to co-owner forever, or on a special arrangement of the parties
• The co-owner has the right to apply to the owner for any issues related to the maintenance of the dog
• The owner grants the co-owner the possibility of free hosting / overexposure of the dog for the period max 10 days
